## STIPULATION

1. On or about February 23, 1989 a formal complaint was served upon the Respondent alleging certain acts of judicial misconduct.

- 2. Respondent hereby stipulates that he did commit the following acts of judicial misconduct while serving in his capacity as Judge of South District Court, Pacific County, Washington:
  - 2.1 Respondent did on three occasions act in an injudicious manner in statements made in open court in the following cases: State v. Trusty, State v. Freshley, and State v. Taylor;
  - 2.2 Respondent did improperly dismiss the following cases against criminal defendants in his court without giving appropriate notice or opportunity to be heard to the governmental authority bringing said charges: State v.

    Doherty, State v. Burton, State v. Bennett, State v. Laughton, State v. McGuire, State v. Beres Ford, State v. McKenzie, State v. De Biaso, State v. Crossman, State v. Seusenboch, State v. Milam, State v. Freeland, State v. Whitting, State v. Willis, State v. Jones, State v. Pointer, State v. Blair, State v. Elo, State v. Blodgette, State v. Lomssies, State v. Powell, State v. Neary, State v. Holland, State v. Kosa, and State v. Armstrong; and
  - 2.3 Respondent sat as a judge in matters involving individuals whom he had previously represented as an attorney in private practice, including the following persons: Marle Alan Sholin, Daniel S. Gill, Raymond Yaun, Donald Oman, Dan Moravec, Steve Moravec, Artie Cope, Brenda Berrier, John Boch, Peggy Paris and David A. Andrews.
