Pursuant to WAC 292-12-010(6) of the Commission on Judicial Conduct Rules as revised and adopted on December 5, 1989 ("CJCR"). The Commission on Judicial Conduct ("Commission") and Honorable Douglas E. Goelz, ("Respondent"), judge of the District Court of Pacific County, Longview, Washington do hereby stipulate and agree as provided for herein. The Commission has been represented in these proceedings by David D. Hoff of Riddell, Williams, Bullitt & Walkinshaw and the Respondent has been represented by Richard F. Broz and Alice L. Blanchard of Mikkelsen, Broz, Wells & Fryer.

STIPULATION

1. Respondent hereby stipulates that while serving in his capacity as a part time District Court Judge of Pacific County, Longview, Washington, on December 6, 1988, he entered into a contract with the Pacific County Prosecutor's office to act as an attorney handling paternity cases in Pacific County.

2. The Commission finds that Respondent's conduct, described above, was a technical violation of the Canons and although

1 inadvertent, does constitute a violation of Canons 1,2,3,(c)(1)(c),  
2 3(c)(1)(d)(111) and 5(c)(1). Accordingly, pursuant to RCW 2.64.055  
3 and 2.64.010(1), the Commission cautions Judge Goelz not to  
4 continue the conduct described in Paragraph 1 above.

6 3. Respondent does hereby agree to accept admonishment as  
7 described in RCW 2.64.010(1) and further agrees that he will not  
8 repeat the violation in the future.
