I. STIPULATION

Pursuant to Article IV, Section 31 of the Washington Constitution, RCW ch. 2.64, and CJCRP 23, the Washington Commission on Judicial Conduct ("Commission") and the Honorable Merle Wilcox stipulate and agree as follows:

- 1. The Commission alleged in a statement of charges, that Judge Wilcox failed to comply with the Commission's December 1, 1995, Order of Censure and by this conduct has violated the Code of Judicial Conduct.
 - 2. Judge Wilcox denies these allegations.
- 3. The parties agree that the interests of justice will best be served if this stipulation is entered and approved, as set forth.
- 4. Judge Wilcox agrees that his execution of this Stipulation constitutes his resignation from office, effective as of January 1, 1997, as set forth in the attached resignation letter.
- 5. Judge Wilcox agrees that after December 31, 1996, he shall not serve in any judicial position that is subject to the Code of Judicial Conduct.
- 6. The Commission shall close this matter without further proceedings, effective January 1, 1997.
- 7. This Stipulation shall not become effective until approved by the Commission on Judicial Conduct. If the Stipulation is not accepted, the matter will proceed as though this Stipulation was not entered into.
