
Dear Mr. Akana,

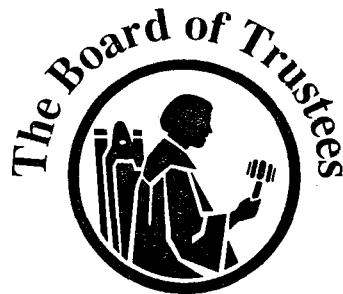

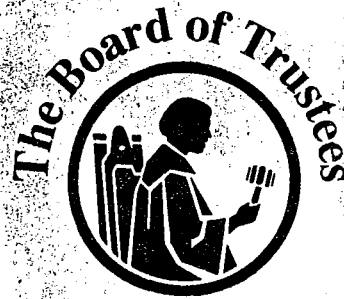
