
8 I arrived at the premises noted above at 5:36 p.m.

22 "Yes" and opened the door and stepped back, allowing
24 room for me to enter. I stepped inside. Carol Chow
26 then asked "What do you want?" I said, I have a
28 delivery for Jody. She asked "What?" I then showed
30 her the papers I was there to serve on Jody. Then
32 Carol Chow said "You'll have to step outside. I'll
34 get her." She closed the door and went back into
36 the kitchen. When I was outside I went to the
kitchen window, looked at Jody, and said "Jody, I
have something for you." Then Carol Chow closed the
kitchen blinds on me and hustled Jody out of the
kitchen. After about 4 minutes Glen Tamura, Jody's
brother, opened the door and said "She must have
left." I said "OK, I'll give these documents to
you" and I handed the documents to him. He refused
to take the documents from my hands. So I left the
documents at his feet just inside the door. Then
Carol Chow picked up the documents, came out of the
house, threw the documents at me saying "I'm not
accepting these, I'm not accepting these." I then
left the premises. The documents remained on the
premises where Carol Chow threw them.
