

Thank you for your patience regarding the availability of training that will satisfy the requirements of the above-referenced case. As I advised you earlier, Thurston County Superior Court Anne Hirsch has been working on a grant to put together a day-long training for judges and court staff in the area of domestic violence. This specifically-focused training is consistent with what the Commission Chair had supported. The training will not take place until September 24, 2012 (a Wednesday). Judge Hirsch let me know yesterday afternoon she has just finalized the arrangements. She also told me there will be either a nominal fee or no fee for judicial officers. I would like to recommend this to the Chair (who could also pre-approve the date, being somewhat after the due date noted in the stipulation). Now that you're chair, I will be working with you on pre-approval for remedial measures ordered in stipulations.

In CJC 6284, Steven Shelton, Puyallup Municipal Court Judge, was required to do "training focused on issues of domestic violence awareness/prevention. Respondent will pay for any costs associated with this training, and agrees to have the training approved in advance by the Commission's Chair, or the Chair's designee."

Chair John Sleeter previously denied pre-approval for some programs proposed by Judge Shelton that were not especially germane. I have since been working with Judge Shelton and AOC to find training that is suitable, and Judge Hirsch in Thurston County has just finalized preparation for the day-long, judge and court-staff focused program described below. Between the AOC representative and Judge Hirsch, I feel confident the training will be worthwhile. Judge Shelton agreed, and asked that I recommend it to you, which I do. It wouldn't be completed within the one year deadline contemplated by the order, but that is not unusual. Unfortunately, remedial programs appropriate to our cases are few and far between. May I tell him you have preapproved this program?
