## Hello Reiko

This is my report on my work with Commissioner Parise. I am pleased to tell you that he has successfully completed his course of counseling.

As I told you in an interim report on April 1. 2014, I was working with Comm. Parise with a three part program that 1) directly addressed his problematical behaviors on the bench, 2) developed his insights into the triggers for those reactions, and 3) explored his personal history to find the sources for those triggered reactions.

Commissioner Parise not only cooperated with this program, but embraced it, and employed his own initiative in investigating the issues that brought him to the attention of your Commission. He took his own three generational survey of his personal history by interviewing his own mother, his wife and his children to gain their feedback about how they experienced his behavior. He reported those conversations to be productive, and entertaining at times for all.

In addition, he kept notes each day about his own reactions to provocative defendants who appeared before him. He said that such defendants no longer elicit what his staff had termed "the wrath of Parise", and that both he and his staff felt good about that.

He also reports that every morning on his three block walk to the courthouse he checks out his own mood to make sure he is feeling happy and patient so that when he arrives at his chambers and dons his robe he will assume the bench as "the happy, patient commissioner". He finds this a very effective way to begin the day, and hopes to end the day in the same condition.

I am pleased to send you this report, and hope it suffices for your purposes. Please contact me if you have any questions, and thank you for referring this interesting matter.
