

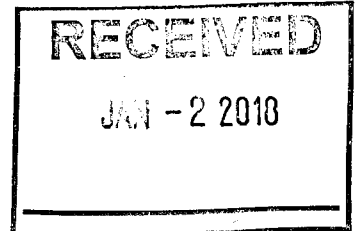

Dear Ms. Callner:

In compliance with the Stipulation, Agreement and Order of Censure entered on September 29, 2017, in the above-referenced case, I hereby affirm that I am aware of no matters with decisions pending beyond ninety days. My bailiff, Lisa Tran, has worked with me to diligently maintain a list of matters pending decision. I have attached a copy of the running list she began maintaining in June; you will see that my rulings have been extremely prompt. She agreed to sign this letter as well, to affirm that I have been promptly addressing rulings, and that I have accurately described the matter below.

In an abundance of caution and candor, I want to inform the Commission that it came to my attention for the first time on September 15, 2017 that Ms. Tran had failed to bring to my attention a matter where a *pro se* litigant had filed documents entitled Motion to Stay Judgment, and Motion for Judgment and Relief From Order, in the case of *Golubeva v. Pistrak*, King County Superior Court Cause No. 15-3-06019-1 SEA. I presided over Mr. Pistrak's dissolution trial on November 7-10, 2016. I issued my written Findings of Fact, Conclusions of Law, and Decree of Dissolution on November 18, 2016. Mr. Pistrak filed a motion for reconsideration on November 28, 2016 which I denied on December 27, 2016. On January 17, 2017 Mr. Pistrak filed a Notice of Appeal with Division One of the Court of Appeals requesting review. Mr. Pistrak continued to file motions before King County Superior Court family law commissioners, and one motion for clarification properly set before me on January 25, 2017. I denied that motion on January 30, 2017. For the next several months, Mr. Pistrak's many other motions were properly ruled on by the court's family law commissioners, by a commissioner or judge sitting in the Ex Parte Department, or by the judge presiding over the supplemental proceedings

calendar. In April, three months after filing his notice of appeal, and four months after I had denied his motion for reconsideration, Mr. Pistrak filed a Motion to Stay Judgment, and Motion for Judgment and Relief from Order, noting them before this court. Ms. Tran did not bring these motions to my attention, believing they were improperly noted before me given the appeal, the motions in the Family Law Court, and the ongoing supplemental proceedings. When they came to my attention on September 15, 2017, I promptly ruled, denying the motions on September 19, 2017. I then counselled Ms. Tran, went over the procedures that we already had in place, and identified that I needed to more closely monitor her communication with litigants. We have redoubled our efforts and I am confident that we can each affirm at this first three-month reporting period, that there are no decisions pending beyond ninety days. In fact, as can be seen from the attached list, there are no decisions pending whatsoever.
