Judge Tracy S. Flood declares:

1. I have had a history of unexplained physical symptoms over the past many months, including during the pendency of the CJC investigation and hearing. On January 2, 2025, I had several tumors removed and biopsied. I continued to have unresolved pain following this procedure. From the biopsy, my doctors confirmed that I have stomach cancer. I was sent to an oncologist for further evaluation and additional treatment.

2. On February 25, 2025, I had my appointment with my oncologist and was diagnosed with an additional autoimmune disease and MALT lymphoma, a rare, slow-growing type of non-Hodgkin lymphoma that develops in lymphoid tissue outside of the lymph nodes. I was experiencing severe abdominal pain, nausea, and fatigue. I have continued to go back and forth to the Seattle VA Medical Center (“VA”) and was referred to the Seattle Cancer Care Gastroenterology Department for another surgery.

3. On July 21, 2025, I am scheduled for an additional

tumor removal and an endoscopic ultrasound at the VA.

4. These symptoms mirror the issues I have faced for months, including those at issue during the CJC proceedings both private and public. My doctors have attributed symptomatology to these conditions. Dealing with these ongoing symptoms has taken a tremendous mental and emotional toll on me.

6. Bremerton Municipal Court is a single court bench with a quarter time Court Commissioner. The City of Bremerton has never had a woman Judge or a black Judge. I was the first black female Judge to be elected in Kitsap County in a contested

election. I am also the only black female to be a part of the City of Bremerton's "Department Head" The court is listed as a Department of the City.


