#### I. IDENTITY OF MOVING PARTY

Appellant by and through her counsel of record, hereby requests a two week extension of time for filing her opening brief – from June 2, 2025, to June 16, 2025.

#### II. FACT RELEVANT TO MOTION

Prior counsel for appellant, Nick Gross, who was cocounsel at the underlying Fact Finding Hearing and was responsible for the day-to-day handling of this matter, left appellant's firm (Frey Buck) on April 25, 2025, taking with him most of the institutional knowledge of the case. While counsel for appellant has been reviewing the material to afford an appropriate submission to the Court, given the volume of material in the case and other practice pressures appellant has been unable to fully address the issues. To serve the interests of the parties and justice, this Court should grant appellant an extension to June 16, 2025, to file her opening brief.
